

Expert Qualifications, Methodology, and Ethical Performance

Chief Justice Nathan Hecht will discuss the relevant legal precedents and case examples related to the expert's ethical duties to the court and the participants of presenting truthful and well-supported opinions, as well as the role of the courts as gatekeeper to keep unsupported testimony and unqualified or unethical experts out.

Chief Judge Hecht, 27th Chief Justice of the Supreme Court of Texas, is a distinguished legal scholar and longest-serving Member of the Court in TX history. He served as a past Lieutenant in the U.S. Navy Reserve Judge Advocate General Corps. He holds a B.A. degree with honors in philosophy from Yale University, and a J.D. degree cum laude from the SMU School of Law.
