Retaking Principles of Valuation Examinations

Participants who have not passed Principles of Valuation course examinations have (1) year from the conclusion of the course to retake or complete the relevant examinations. Retakes may be completed for a fee of \$220 (\$100 for USPAP, for the BV 8-Hour retake the pricing is \$1000 for ASA members and \$2000 for non-members). After payment is received, ASA will contact the participants with further instructions on arranging an exam proctor.

“Challenging” or Testing Out of Principles of Valuation Courses

You may “challenge” or test out of a Principles of Valuation course by reviewing the electronic course materials, and passing the written course examination without attending the course. The option of challenging a course is available only for the Business Valuation and Machinery and Technical Specialties disciplines. You must be a candidate with ASA to challenge the courses.

After payment is received, ASA will contact participants with further information on accessing electronic course materials. Prereading assignments are available on ASA’s website at www.appraisers.org. Students have up to (1) year from the date of purchase to complete the challenge exam.

Exam Proctoring

Proctor arrangements for the Challenge exams must be made by the participant. **Acceptable proctors are: ASA designated members (not from the same firm or office), universities, public libraries and testing centers. ASA does not provide financial assistance or reimbursement for any proctoring services or postage.**
