He was Co-Editor of two legal textbooks, Valuation Strategies in Divorce and Valuing Specific Assets in Divorce published by Wolters Kluwer. For two years, he participated in two mock trials at the Association of the Bar of the City of New York, and participated as a speaker in the Port-Mortem and Estate Planning program of ALI-ABA, the Advanced Learning Institute of the American Bar Association. He has also delivered at four international conferences held by the American Society of Appraisers, and was an AQB Certified USPAP Instructor - Uniform Standards of Professional Appraisal Practice — Recertified. Mr Rosoff served on the Appraisal Foundation's Personal Property Resource Panel and was it's Chair for two years. Furthermore, Mr. Rosoff has testified over 17 times across the United States in Supreme, State and County Courts.
