Election Biography

In 2018 NAIFA merged with the American Society of Appraisers (ASA) upon which she obtained the ASA-RP Designation. She currently serves on the national Real Property Committee with ASA.

Mrs. Henderson has been very active with her state appraiser board having served on several committees. Since 2000, she has been a member of the Disciplinary Committee serving as an Expert Witness and Hearing Panel member. She has been a presenter at past state appraiser board seminars, realtor seminars and practiced with her own appraisal school in the past as well as developed educational programs. In 2018, NAIFA merged with the American Society of Appraisers upon which I earned my ASA -Residential designation. I played an integral part in the process of the merger. Since, I continued to serve in positions with my local chapter and taught courses on the local level. I offered and was elected to the ASA Real Property Committee in 2019. My involvement with the Oklahoma Real Estate Appraiser Board has been in the capacity of serving as a Hearing Panel Member on disciplinary hearings, expert witness for the State Prosecuting Attorney, and a member on the Probable Cause Committee, which functions as a review committee to determine the relevancy of a grievance.

As stated previously I served on many levels for NAIFA holding local, regional and national offices as well as serving on various committees including marketing, education, public relations, etc. As national president in 2015, my hand was in all of it I guess you could say.
